Rules and Regulations

- 1) The number one rule of Lazy Days Campground is "If you are unsure about what to do, ASK MANAGEMENT, not your neighbor.
- 2) Traffic The speed limit at Lazy Days Campground is <u>9 MPH</u>, and is strictly enforced. Do not detour across other people's sites. Stay on the roads. All state traffic statutes relating to the safe operation of motor vehicles will be strictly enforced; including: Driving while intoxicated, reckless driving, and speeding. Passengers are not permitted to ride, sit, or stand on rails or tailgates of trucks, or ride outside of any motor vehicle. Violators will be removed from the campground with no refund. <u>Suspected DWI's and DUI's will be reported to the Washington Co. Sherriff for prosecution.</u>
- 3) **Tents** Screen tents and light weight camping gazeboes are allowed.
 - a) RV Site One tent with a size limit of 8' x 10' is allowed on site for the use of children listed on contract or for storage.
- b) Tent site One large tent (sleeps 4 or more), or two small tents (sleeps 2 or less) Group size is limited to 4 adults, or one single family per site.
 4) Firearms No discharging of any type of weapons and no open carry in the campground.
- 5) Fireworks No illegal fireworks allowed in the campground. Violators will be turned over to the Washington co. Sherriff.
- 6) **No chainsaws** are allowed in the campground.
- 7) All sites must be kept neat and free of debris.
- 8) Vehicles Two vehicles per site. No storing of vehicles on trailers is allowed on your site. Type of vehicles allowed on site is subject to management's discretion. Keep your vehicles on your site, even if adjacent sites are empty. Any damage done to other sites, caused by you or your guests, will be charged to you. No moped's, ATV's, Go-carts, Etc. (Check with office)
- 9) Golf Carts Carts must be checked out by Lazy Days staff. Only drivers 21 and over, with a valid driver's license, may operate the cart. No child on the lap may steer the cart. Insurance is required. Golf carts must park in the cart parking area only, while at the beach. Owner(s) must complete the Golf Cart Requirements Form.
- 10) Boats Due to the abuse of our boat storage rules in the past you may not store your boat on your site, even if you're a seasonal resident. After use, it must be placed in storage. Any violation of this rule will result in you being asked to remove your boat from Lazy Days Campground.
- 11) Guest Policy All guests, except for signatories and their minor children, must pay the visitor fee. \$3.50 per car, per day. \$7.00 for overnight visitors. Visiting hours are 8am 10pm (Sun Thurs), and 8am 11pm (Fri & Sat). No new visitors will be admitted to the campground after 9pm. Campers are responsible for the conduct of their guests.
- 12) Children/Minors Minor children will not be allowed to stay at Lazy Days Campground without adult supervision. Do not leave children unattended in the campground.
- 13) Beach Hours are 8am dusk. No bikes or pets on the beach. No glass bottles on the beach or in the water. No swimming after dark. NO LITTERING on or around the beach area. NO LIFEGUARD ON DUTY. It is the responsibility of the camper to supervise their children and guests. Releasing Lazy Days Campground, Inc. from all liability for any accidents that may occur.
- 14) Pets All pets must be kept on a leash at all times. Do not leave dogs unattended or barking. No pets on the beach. Check with office staff for where your pets can swim. Please pick up after your pets.
- 15) Campfires All campfires need to be contained and fully extinguished before retiring for the evening or leaving the campground. Do not leave fires unattended for an extended period of time. Please do not burn trash, bottles, or cans in the fire pits. Take all trash to the dumpsters. <u>"Locations are on the site map"</u>
- 16) **Cigarettes –** Please carry an ashtray or a soda can. Do not leave cigarette butts on the ground.
- 17) Quiet Time Sunday Thursday 10pm 8am, Friday and Saturday 11pm 8am.
- No loud radios, TV's, voices, or sounds that carry past your site are allowed. Our objective is to provide a peaceful and secure atmosphere for all of our campers. Your cooperation is essential. (This applies to all hours of the day and night). Underage drinking will not be tolerated. Disruptive or disorderly behavior will result in possible arrest or removal from the campground with no refund. All minors must return to their sites during quiet time.

Additional Rules for Seasonal sites - Must submit plans for any changes that you would like to make to the site.

- 18) Sites, and trailers are expected to be kept in a clean and presentable condition. This includes the exterior of you trailer.
- 19) Decks- sections must be placed next to each other, be no larger than 4'x8', no more than one foot off the ground, not exceed trailer length.
- 20) No railings are allowed on the platforms (see management for the exception to this rule)
- 21) No fencing is allowed on your site.
- 22) Lights across awnings only. You may not have lights all over the site and lights must be turned off after retiring for the night or when you are gone for an extended period of time. (ask management for exceptions)
- 23) Cutting the grass of the seasonal sites is not included with the seasonal site fee. If your grass grows above 5 inches, we will cut it and a maintenance fee will be applied to your site.
- 24) Sheds and Deck Boxes Only one shed, is allowed with a size limit of 4' W x 6' D x 7' H. (No wood, or metal sheds), and two deck boxes 41" W x 21" D x 24" H (Maximum size). Existing wood sheds will be allowed, but cannot be replaced with another wood shed.
- 25) Only one face cord may be stored on your site and must be stacked in a neat pile. The use of skids for firewood is ok; however, they must be broken down. No burning of full skids is permitted. Max dimensions H-6' x L-8' x D-18"
- 26) Sale of your trailer In the event that you sell your trailer, your lot will not be included in the sale.
- 27) Non-Transference Your seasonal site will not be passed onto anyone in the event of death or if you leave before the season ends, unless you have a non-resident third party on the contract.
- 28) **Tarps-** No blue tarps. Black, brown, and green tarps are permitted to cover things that would otherwise go in a shed (Ex. lawn mower). Please limit the number of tarps used during the season to two tarps, as they can be an eyesore.
- 29) Tarping your roof- If your roof leaks please let us know. You may cover it with a tarp for no more than 10 business days. Tarps are a temporary fix, not a permanent solution. Tarps for winter storage must be removed by may 1st.

1) I/We the season lessee(s), listed above, will maintain insurance coverage for damage to his/her property while parked or stored at Lazy Days Campground, Inc. It is fully understood that Lazy Days Campground does not assume any responsibility for damage of equipment or personal property of lessee(s).

2) I/We the season lessee(s), listed above, understand that no refund of site rental will be made in the event that the lessee(s) shall leave earlier than the season closing date; Either by my own volition, or at the request of management.

3) I/We understand that a Lazy Days Campground Season Sticker is required to be permanently attached to the lower passenger windshield. (2 Per Site)

4) I/We the season lessee, understand that if we acquire, or use any of the items listed on page 1 of this contract, Lazy Days Campground will make the appropriate changes to this contract, and I/we will be charged for those items.

5) I/We the season lessee, listed above, understand that any violation of Lazy Days Campground, Inc.'s rules, or failure to comply with the payment schedule that was issued to me, can result in my/our removal from the campground, without refund, by management. It is further understood that if I vacate the site for any reason during the season, management has the right to use the site.

6) I/We the season lessee(s), listed above, understand that payments are due within the 5day grace period from our payment date(s), and failure to pay within the grace period will result in a \$25.00 late fee added to my/our balance. If payment is not received for two consecutive months, I/We understand that a final 5 day notice will be given to pay in full, or remove our belongings from the property of Lazy Days Campground, Inc.

7) I/We the season lessee, listed above, understand that payment(s) made with tax returns (per managements' discretion) are due no later than May 1^{st,} and a deposit is still required to reserve my/our site. If payment is late, payment(s) made with tax returns will no longer be an option for all upcoming seasons. No exceptions.
